Ms. Morse,

Good evening. I have been forwarded a letter dated December 15, 2021 that you sent to Mayor McFadden regarding the employment of Johnny Gonzalez, a part-time police officer with this agency. Mr. Gonzalez was appointed as a part-time police officer in July 2021 and has been working in that capacity since.

Apparently, I made a huge mistake when I recommended his hire to the Village Board who appointed him. I'm not sure how or why I did this without confirming his eligibility and I apologize for this error.

Mr. Gonzalez was employed by the Rockland County Sheriff's Office as a Security Aide and he does in fact have a Security License issued by the NYS Licensing Division (see attached). Mr. Gonzalez graduated from the Rockland County Police Academy as well. As far as the college credits, he did earn credits from

the Rockland County Community College and he is working on obtaining his transcript. The number of credits he has earned is not clear at this time and I won't know until he obtains the transcript.

What do you recommend I do with his employment status in the mean time?
