Re: Draft of Local Law regarding Streets and Sidewalks (Chapter 83)

Dear Mayor McFadden:

As per the direction of the Board at the September 21, 2022 Village Board Meeting, we are providing the attached, revised Local Law regarding Chapter 83 (Streets and Sidewalks) to remove two provisions as recommended by the Building Inspector.

The initial draft of this Local Law would have amended Section 83-4(B) regarding time restrictions on road work. As per the suggestion of the Building Inspector and as discussed by the Board, the Board requested 83-4(A) and 83-4(B) to be removed from the draft Local Law. For the Board's information, below is the current language of Section 83-4 in the Village Code which will be removed in its entirety under this proposed revision of the Local Law:

§ 83-4. Time restrictions on road work.

A. Road closings. Except as otherwise permitted by the Board of Trustees, no road shall be closed to traffic for repair or other purpose for more than 24 hours.

B. Completion of road work. All road work must be completed as expeditiously as possible and in all cases within 60 days of the start of the work.

The Public Hearing on this Local Law was continued to October 20, 2022.
