Tinka,

In response to your January 5, 2023 email, Jim Hays and I prepared the following response.

If we use the 2018 GHG inventory the Village used a total of 1,287,976 KWh of electricity. At current O & R rates of .165 dollars/KWh the cost is \$212,516.04

Applying the NYPA offered rates the savings would be as follows:

- 1. can we get an analysis of what the Village would pay annually in each option, 1,2,3 years
- 2. what grants would offset the higher cost for options 2 & 3?
- 3. what is the likelihood that the Village of TP would receive any grants? Based on our unsuccessful (so far) WIIA applications for grants, I am hesitant to agree to sign for more expensive energy, unless we are guaranteed grants to offset the higher costs.
