David,

Village of Tuxedo Park's insurance policy includes property coverage on the bath house at 77 Wee Wah Road. This means 77 Wee Wah Road is automatically a covered location for liability. The amenities you have there are akin to a public park and it's not necessary to specifically list anything for liability coverage.

Should you decide to take over running the beach next summer season, a liability premium will only be charged if it increases your budgeted expenditures in some way. Please let us know if you do decide to take over beach operations next summer as there will be some underwriting questions (mostly about controls & safety) that need to be answered.

Lastly, the Village's insurance policy includes coverage for alcohol related claims because you are not "in the business" of selling or serving alcohol.

As you may know we allow property owners on Pond No. 3 and Wee Wah Lake to swim at their own risk. The Village owns a property on Wee Wah lake that we allow all resident and non-resident property owners and their attended guests to use. It is laid out as a perk with barbeque stands, basketball, volleyball, a lavatory, parking and swimming. We do not sell or prohibit alcohol. This park has been open for many years. I just want to double-check that our policy covers all potential liabilities?
