Devereux – 178 Continental Road, Parcel No. 104-1-54, Removing existing tiered deck and replace with single level deck:

The applicant appeared before the BAR, after the BZA granted approval for a variance, on April 6, 2022. The BZA granted relief from Section 100-8, "Minimum area and bulk regulations," of the Village of Tuxedo Park Zoning Law to the property identified on the Tax Map as Section 104, Block 1, Lot 54, in the form of a variance of 18.5 feet from the required 50-foot rear yard setback to 31.5 feet from the sole purpose of constructing a deck on the rear of the house.

Neighbors were noticed two times and no negative responses were received.

The applicant's architects gave a brief recap of the proposed plans with a shared screen review. There were no changes to the plans as originally presented to the BAR. Stone samples were provided for the Board members to preview. Some design details discussed included a Chippendale style lattice fencing, sealed Ipe for the stairs and deck and window trim in white.

Member Boshears questioned if Ipe decking was barred in the past. It was confirmed Ipe was approved in the past.

Chair Tralins made a motion to approve the application as referenced by the BZA to approve removing the existing tiered deck and replace with a single level deck. Site drawings prepared by Northworks Architects, LLC, consisting of a "Permit Application" cover sheet and the following: Existing/Proposed Site Plan, sheet AO.1, signed by Neil R. Young, dated January 7th, 2022; Existing/Demo Basement Floor Plan, sheet A1.0; Proposed Basement Plan, sheet A1.1; Existing First Floor Plan, sheet A1.2; Proposed First Floor Plan, sheet A1.3; Existing North Elevation, sheet A2.3.

The motion was seconded by Member Aaron.

The vote of the Board was 3 - 0 in favor of the motion.
