### Authorizing Legal Services by Village Special Counsel in Litigation Resolution 1104-02

WHEREAS, the Village Board of Trustees for the Village of Tuxedo Park ("Village") desires to enforce the Village Code and New York State Fire and Building Codes to promote the public health safety and welfare of residents, first responders, and others accessing properties within the Village; and

WHEREAS, the Village Building Department and Code Enforcement Officials have previously issued orders directing dangerous and unlawful work at 116 Tower Hill Road West to cease unless and until such work is properly approved; and

WHEREAS, upon information and belief, the property owner continued to carry out work after the issuance of such violations and stop work orders in continued violation contrary to the provisions of the Village Code and New York State codes; and

WHEREAS, the Village desires to ensure that safety of all persons that may be impacted and placed at risk by the improper use of such property.

NOW, THEREFORE, it is resolved as follows:

- <u>Section 1</u>. The above "WHEREAS" clauses are incorporated herein as if set forth in full.
- Section 2. The Village Board hereby authorizes Special Counsel, Feerick Nugent MacCartney, PLLC, to take any and all measures necessary to bring a legal proceeding in the County of Orange and/or any other appropriate forum to pursue a judicial order and such other relief necessary to enjoin and cease the continued building and development unless and until any and all appropriate approvals are obtained in relation to such use.
- Section 3. The Village Mayor, and any other employee, official or consultant, as directed by the Mayor, is hereby authorized to take any and all necessary actions to carry out the provisions of this Resolution.
- Section 4. This Resolution shall be effective immediately.
