The law reads that you can only put in temporary docks. Trustee Brooke suggested that we only allow permanent docks because the quality of workmanship of a permanent dock is better than that of a temporary dock.

WHEREAS, Special Counsel Feerick Nugent MacCartney, PLLC for the Village has approved the settlement of this matter as recommended and all professionals employed by the Village recommend that it is in the best interest for the Village to resolve the litigation entitled <u>Said and Karen Haider v. The Assessor of the Village of Tuxedo Park, The Board of Assessment Review of the Village of Tuxedo Park and the Village of Tuxedo Park, under Index No.: EF002496/2022 for the assessment year 2022 (the "Litigation"), pursuant to the terms and conditions set forth in the settlement documents annexed hereto as Exhibit "A".</u>

NOW, THEREFORE, be it is resolved as follows:

Section 1. The above "WHEREAS" clauses are incorporated herein by reference as if set forth fully.

<u>Section 2.</u> The settlement of the litigation is hereby approved and Special Counsel aforesaid for the Village is hereby authorized to execute a Consent Order to resolve the Litigation upon the terms and conditions set forth in the settlement documents annexed as Exhibit "A", because such a settlement of the Litigation is in the best interest of the Village.

Section 3. Resolution shall be effective immediately.
