#### Open the Public Hearing on Draft Local Law #1 of 2023 <u>Resolution 0626-06</u>

Be it resolved that the Board of Trustees continue the Public Hearing on Local Law #1 of 2023 – Revising the Lake Laws Related to Dock Size.

Mayor McFadden asked if anyone from the public had any comments.

Claudio Guazzoni de Zanett said that the Board should think twice before changing anything about the lakes. We've had problems with the lake such as quality of water and milfoil. Increasing boat and dock size would be for the benefit of a few to the detriment of the many. Mr. Guazzoni de Zanett reminded the Mayor that he had promised to issue a survey.

Mayor McFadden responded that this local law is on indefinite hold. He said that he will keep his commitment to have a survey.

Jim Hays addressed the Board, saying that the survey would be very important. The results of the survey would greatly inform the Board's discussion. Dr. Hays said that there has been a lot of discussion in the community about this and about the power and speed of boats. Because of new technology, electric boats can go a lot faster than they did when the old law was put into effect. Dr. Hays suggested that the survey should include whether or not people want to see some limitation in the horse power or speed of the boats on the lake.

Mayor McFadden agreed with Dr. Hays.

Chiu Yin Hempel addressed the Board about some white slime that is floating on the water. Also, seaweed seemed to be just beneath the surface of the lake. She said she was not sure what it was, but that this should be looked into as soon as possible. Ms. Hempel said that we do not understand how to make our water truly healthy. We need to get a firm handle on the milfoil, algae and other lake-related problems before we introduce bigger docks and bigger boats with bigger engines which could (she emphasized that she didn't know for certain) exacerbate the problems, and which could cost the Village a lot of money to remediate. Ms. Hempel said that the lake was a communal resource and a critical one. It was not just a pleasure pond for the boat owners and the people who live around the lake.

Mayor McFadden said that we were waiting for permits to continue doing algae treatments on the lakes.

Trustee Scherer said that in November there was a survey of the lakes that showed that all milfoil had been eradicated. The lakes manager from last year was on the agenda to be approved to

continue work on the lakes this fiscal year. Trustee Scherer hoped that we would get to the bottom of this very quickly.

Dr. Hays responded that milfoil absorbs phosphates. He suggested that it was possible that in the absence of milfoil, phosphates were left over for other plants. Dr. Hays said it was likely that other plants, maybe natives, would become much more plentiful. If the milfoil wasn't there to use it something else would.

Mayor McFadden said that people on Pond #3 had noticed that there was a lot of aquatic plant growth, which they thought might be milfoil. The Mayor said that it was not milfoil, it was a weed that was now able to grow because the milfoil is no longer there.

Allen Barnett agreed with what had been said. He said this issue had the potential to cause damage to the environment, damage to the esthetics, damage to the value of the Park. He said that the Lakes Committee should be involved with this. Mayor McFadden agreed.

No further comments were received.

# Adoption of Local Law #2 of 2023 Approving Annexation of Two Parcels of Land From the Town to the Village Resolution 0626-11

WHEREAS, Rattlesnake Mountain Preserve LLC, submitted a petition seeking to annex two (2) parcels of land located in the Town of Tuxedo ("Town"), which is designated on the Town tax maps as Section 208, Block 1, Lot 25 (formerly S/B/L 8-1-25) and Section 209, Block 1, Lot 26 (formerly S/B/L 9-1-26) (collectively "the Territory"); and

WHEREAS, it is the responsibility of the Village Board to consider and evaluate the potential benefits and impacts of annexation; and

WHEREAS, a joint public hearing was conducted on January 23, 2023 to provide an opportunity for residents and stakeholders to express their views and concerns regarding the proposed annexation; and

WHEREAS, the Village Board has thoroughly reviewed the proposed annexation; and

WHEREAS, the Village Board has determined that the annexation of the Territory is in the best interest of the Village of Tuxedo Park and its residents; and

WHEREAS, the Village Board desires to adopted a local law to finalize such annexation.

NOW, THEREFORE, BE IT RESOLVED that:

The Village Board hereby adopts a Local Law No. 2 of 2023 entitled, "A LOCAL LAW OFFICIALLY ANNEXING INTO THE VILLAGE OF TUXEDO PARK CERTAIN PARCELS OF PROPERTY PREVIOUSLY LOCATED IN THE TOWN OF TUXEDO AND IDENTIFIED ON THE TOWN TAX MAPS AS SECTION 208, BLOCK 1, LOT 25 (FORMERLY S/B/L 8-1-25) AND SECTION 209, BLOCK 1, Lot 26 (FORMERLY S/B/L 9-1-26)."

- Section 2: The Territory shall be incorporated into the Village of Tuxedo Park and become subject to all applicable laws, ordinances, and regulations of the Village and the owners of the annexed parcels of land shall be responsible for paying all necessary fees, assessments, and taxes associated with the annexation.
- Section 3. The Mayor, and any officer, employee or consultant as directed by the Mayor is hereby authorized to take any and all actions necessary to carry out the provisions of this Resolution, including, but not limited to, effectuating any necessary adjustments to zoning or land use regulations and the Village Zoning and official map to reflecting the annexation of the Territory.
- Section 4. The annexation of the Territory shall be consistent with the Resolution, Order and Finding adopted by the Village Board on April 19, 2023.
- Section 5. The Village Clerk is hereby directed to enter said Local Law into the minutes of this meeting and in the Local Law book of the Village of Tuxedo Park, and to give due notice of the adoption of said Local Law by filing the Local Law in the Office of the Secretary of State in the State of New York.
- Section 6. This local law shall take effect immediately upon filing with the New York Secretary of State.
- <u>Section 7.</u> This Resolution shall be effective immediately.
