**Resolution Transferring the Conduct of Village Elections  
to the Orange County Board of Elections**  
**Resolution 1115-04**

WHEREAS, the Village of Tuxedo Park has been conducting its own elections pursuant to New York State Election Law Article 15 and Village Law §3-312, and

WHEREAS, the Village Board of Trustees has determined that it would be more efficient for the Village to transfer the conduct of Village elections to the Orange County Board of Elections (the “County Board”), given the County Board’s resources and their experience and expertise in conducting municipal elections, and

WHEREAS, if the County Board conducts the Village elections, the Village may choose its own election inspectors from within the Village, from a list provided by the County Board, and

WHEREAS, if the County Board conducts the Village elections, the Village Clerk and other Village Officials may be present at the polls when they close and observe the counting of the votes, including all absentee ballots, and\

WHEREAS, the County Board will receive nominating and other petitions in accordance with New York State Law and provide all required publication and notices and compensate all election workers in accordance with New York State Law, and

WHEREAS, in accordance with Election Law §4-104, the Village shall submit to the County Board a list of polling places for Village elections, and the polling place(s) shall be designated by the County Board in consultation with the Village, and

WHEREAS, upon a transfer of the conduct of the Village elections the elections may continue to be held on the third Tuesday in June, as now permitted by New York State Election Law Article 15.

NOW THEREFORE, BE IT:

RESOLVED, that in accordance with New York State Election Law §15-104(1)(c), the Board of Trustees determines that Village of Tuxedo Park elections shall be conducted by the Orange County Board of Elections, and it is further

RESOLVED, that upon such transfer, and so long as permitted by New York State law, Village of Tuxedo Park elections shall continue to take place on the third Tuesday in June, and be if further

RESOLVED, that this resolution is subject to a permissive referendum as provided in Article 9 of the New York State Village Law and is not effective until either (a) the applicable time period has elapsed to file a petition for a referendum, and no such petition has been timely and properly filed, and (b) if such a petition has been timely and properly filed, a referendum has been conducted approving this resolution, and it is further

RESOLVED, the Village Board of Trustees authorizes the Village Clerk to take such action as may be necessary to effectuate the terms of this Resolution.
