West Lake Road Bridge Project
Resolution 0416-04

Mayor Citrin discussed the West Lake Road Bridge Project. West Lake Road Bridge is just south of the intersection with Eagle Mountain Road. It has been deteriorating for years. The curb line has continued to eat away into the north bound lane. There was no question that it had been replaced. Because of the nature of the job, which includes a culvert under the bridge to allow water to pass, it was decided that it would be sent out for bid. A Request for Proposals was

prepared and five bids were received. The sealed bids were opened on April 4th in the presence of the Village Clerk, Mayor Citrin, DPW Supervisor Jeff Voss and Jake Werling of Colonnelli Brothers, Inc. (one of the bidders).

Election Date Referendum
Resolution 0416-05

WHEREAS, on November 15, 2023, the Village Board of Trustees duly adopted Resolution 1115-04 transferring the conduct of village elections to the Orange County Board of Elections, given the County Board's resources and their experience and expertise in conducting municipal elections; and

WHEREAS, general village elections held in and for the Village of Tuxedo Park are currently held on the third Tuesday of June and all the election districts contained within the village are located wholly within the village and County of Orange; and

WHEREAS, on January 27, 2025, Grand Jury Term 6 of the Orange County Court, pursuant to its authority under Criminal Procedure Law § 190.85(1)(c), issued its Report #2025-001 recommending, among other things, "that village boards move village elections to Election Day in November to enhance voter participation and not impede the efficiency of the Orange County Board of Elections"; and

WHEREAS, the Village Board of Trustees agrees with and adopts the recommendations made by Grand Jury Term 6 with respect to moving village elections in the Village of Tuxedo Park to coincide with the date of the general election in November to enhance voter participation and facilitate the efficiency of the Orange County Board of Elections; and

WHEREAS, pursuant to Election Law § 15-104(1)(c), the Board of Trustees of the Village of Tuxedo Park may adopt a resolution providing that village elections shall occur on the day of the general election; and

WHEREAS, resolutions providing that village elections shall occur on the day of the general election are typically subject to a mandatory referendum under Election Law § 15-104(1)(a) and Village Law § 9-912.

NOW THEREFORE, BE IT:

RESOLVED, that in accordance with Election Law § 15-104(1)(c), the Board of Trustees determines that village elections shall occur on the day of the general election in November; and it is further

RESOLVED, that this resolution is subject to a mandatory referendum as provided in Article 9 of the New York State Village Law and shall not become effective until a referendum has been conducted approving this resolution; and it is further

RESOLVED, that the Village Clerk is authorized to take such action as may be necessary to effectuate the terms of this Resolution.
